Agreement for Electronic Delivery of Tax Bills

This agreement is to provide for electronic delivery of tax bills pursuant to Texas Property Tax Code (TPTC) §31.01. The agreement only applies to the individual or entity that is entitled to receive a tax bill under TPTC §31.01. Before executing this agreement, all applicable laws and rules must be reviewed carefully, including TPTC §31.01. If answers to questions are needed, legal advice from an attorney should be sought.

NOTE: Any information provided in this agreement is a public record subject to disclosure. To the extent that any information in this agreement might otherwise be confidential pursuant to law, such confidentiality is waived. By signing this agreement, you affirmatively consent to the release of all information provided in this agreement.

Agreement for Electronic Delivery of Tax Bills

NOTICE: THIS AGREEMENT REMAINS IN EFFECT FOR ALL SUBSEQUENT TAX BILLS PURSUANT TO TPTC §31.01 UNTIL THE EARLIER OF THE FOLLOWING: (1) YOU ARE NO LONGER ENTITLED TO RECEIVE A TAX BILL UNDER TPTC §31.01 (FOR EXAMPLE, THE PROPERTY IS LISTED IN ANOTHER PERSON'S NAME DUE TO THE SALE OF THE PROPERTY); OR (2) THE AGREEMENT IS REVOKED BY AN AUTHORIZED INDIVIDUAL IN A WRITTEN REVOCATION FILED WITH THE ASSESSOR.

EXCEPT AS OTHERWISE PROVIDED BY LAW, FAILURE TO SEND OR RECEIVE A TAX BILL REQUIRED BY TPTC §31.01, INCLUDING ANY TAX BILL TO BE DELIVERED BY ELECTRONIC MEANS PURSUANT TO THIS AGREEMENT, DOES NOT AFFECT THE VALIDITY OF THE TAX, PENALTY, OR INTEREST, THE DUE DATE, THE EXISTENCE OF A TAX LIEN, OR ANY PROCEDURE INSTITUTED TO COLLECT A TAX.

THIS AGREEMENT IS NOT EFFECTIVE UNLESS AND UNTIL IT IS SIGNED BY BOTH THE ASSESSOR AND THE INDIVIDUAL OR ENTITY ENTITLED TO RECEIVE A TAX BILL UNDER TPTC §31.01.

A person who signs this agreement on behalf of an entity affirmatively represents that he or she has authority to enter into this agreement on behalf of the entity.

If you make a false statement on this form, you could be found guilty of a Class A misdemeanor or a state jail felony under Section 37.10, Penal Code.
